#### A. Current Month Activities:

A1 - Continued work on the 2018 ESA pumping station prevent maintenance program.

- A2 Vac-Con Truck #34; preformed general preventive maintenance on the vehicle.
- A3 Maintenance Garage; installed a steel hold in-place chain on the ESA work bench acetylene tank.
- A4 Expired ESA portable steel air tanks; cut the tanks in half for proper garbage disposal.
- A5 Old Orchard, Circle, Brookwood, Eaton Crest, Country Club, and the Wampum Park pumping stations; vacuumed the wetwells and cleaned the pump float controls and transducers.
